## APPLICATION:

### For the hygienic hand disinfection:

Rub undiluted product into hands and keep them moist for the entire contact time. Manorapid® basic is already effective after 15 seconds. According to the current state of the art we recommend a contact time of 30 seconds.

### For the surgical hand disinfection:

Rub undiluted product into hands and lower arms and keep them moist for 1.5 minutes.

Prior to use of electrical devices skin areas treated with Manorapid® basic should be rubbed dry. Lanolin-poly(oxyethylen)-75 may cause local skin reactions (e. g. contact dermatitis).
