## Application:

### For hygienic hand disinfection:

Rub undiluted product into hands and keep them moist for the entire contact time. Manorapid® r.f.u. is already effective after 15 seconds. According to the current state of the art we recommend a contact time of 30 seconds.

### For surgical hand disinfection:

Rub undiluted product into hands and lower arms and keep them moist for the entire contact time. Manorapid® r.f.u. is already effective after 1 minute. According to the current state of the art we recommend a contact time of 1.5 minutes.

## Physical and chemical characteristics:

Appearance: clear, colourless liquid

Scent: alcoholic

pH-value: 6 – 8 at 20 °C

Density: approx. 0.9 g/cm³ at 20 °C

Flash point: <23 °C according to DIN 51755

## Composition (active ingredients):

100 ml contain: 70 ml Propan-2-ol

## Special advice:
